Attorney **Russell Speidel** spent a significant portion of the year working with volunteer Washington Fellows of the American College of Trust and Estate Counsel (ACTEC) to draft new state legislation in light of the Washington State Supreme Court ruling in *"Estate of Rathbone."* The intent of the proposed legislation is to clarify the authority of a personal representative with nonintervention powers to administer an estate.

Attending the Annual Meeting of ACTEC in San Antonio in March, and the Seattle Annual Estate Planning Seminar in November enabled Mr. Speidel to stay abreast of current developments in the areas of fiduciary income tax, fiduciary litigation, charitable planning, estate and gift tax, elder law, business planning, and powers of appointment. For the 12<sup>th</sup> consecutive year he was named a Super Lawyer, one of the top five percent in the state, by the magazine, *Washington Law & Politics*. This December, Mr. Speidel concludes a 2-year term as Treasurer of the statewide Board of Directors of Northwest Justice Project. Locally, he joined the Board of the Wenatchee Downtown Association this year and continues over 25 years of service on the Advisory Board of The Salvation Army, Wenatchee Corps.

Attorney **David Bentsen** contributed to our profession and our community by presenting seminars this year regarding Trusts and Alternatives to Trusts; Estate Planning for Indian Tribal Members by the Non-Indian Law Attorney; and Wills and Estate Planning Concepts.
